Elizabeth Sipple provided an overview of the grant and the process for making award decisions. She further reminded board members that all information discussed is confidential, and that WLEB members with a conflict of interest can share fact based information if questions arise but should not participate in making a specific recommendation or voting on that funding decision.

Elizabeth Sipple noted that there were 63 applicants with a total funding request was \$2.4 million. Elizabeth reminded the board that the total available funding for this grant is \$611,269.
