Kristina Sweet reminded WELB that there are 45 applications requesting more than \$6 million, and there are \$750,000 available to award in the final round. Kristina Sweet noted that reviewers have recommended \$3.9 million to move forward, but this is still far beyond what is available so WLEB will need to further reduce that today to around \$1.5 million. Kristina Sweet reminded WLEB members that the goal is to only invite back businesses to go through the effort of drafting a full application if they are likely to receive funds.
