Decision Making Overview – Elizabeth Sipple

Elizabeth provided an overview of the Supply Chain Impact Grant and ARPA Primary Producer Impact grant review process and decision-making plan for the day.

Supply Chain Impact Grant Decisions – Elizabeth Sipple

Elizabeth updated the board on the high demand for the Supply Chain Impact Grant and informed the board that there were 14 applicants with a total request of \$2.2M, which is an oversubscription of \$1.5M. Elizabeth informed the board that currently the reviewers are putting forward eight applications for discussion and that those eight applications represent an overspend of \$400k.

Reviewers provided an overview of the eight applications currently recommended, including the business and project overview.

Elizabeth reminded the board that farmworker housing requests were steered to this pool.
