Key Questions for Small Group Discussions:

- Is there agreement within the group on the proposed maximum and minimum award amounts for business grants and service provider grants? What are the concerns, if any?
- Are there specific ineligibilities the WLEB wants to highlight for Businesses Enhancement Grant applicants, TSAG applicants, or Service Provider applicants? Conversely, are there specific funding priorities the WLEB wants to highlight?
- Does the WLEB want to eliminate match requirements? Or reduce the match to 25% or 50% of
 grant requests? Or make changes to the match waiver process? For example, eliminate wording
 around match being required since it is actually not required as long as the business can provide
 a clear rationale for not providing match. Instead frame it as 'XX% match is recommended by
 the WLEB'.
- In FY25 does the WLEB want to highlight that 'cost of doing business' projects will not be competitive in the application guide? And if yes, how would 'cost of doing business' projects best be defined? Please develop a list of examples of 'cost of doing business' projects per sector. Examples are very helpful to applicants.
